CREDIT TERMS AND RETURN POLICY

1. All accounts are due on the 10th of the following month.
2. All accounts not paid by the 20th of the month are considered overdue.
3. All accounts still overdue on the last business day of the month will have 2% interest added to the past due amount.
4. All service charges are due and payable.
5. All accounts with a past due balance, to include service charges, that are over 30 days will be placed on C.O.D.
6. All C.O.D. accounts must have their credit rating re-evaluated before being re-instated to open account.
7. Repeated delinquency may result in permanent loss of credit privileges.
8. Any check returned for insufficient funds, customer will be charged a \$25.00 bank fee (along with any additional collection fees) and account placed on cash only.
9. All merchandise returned for credit (excluding cores) must have an RMA# provided by ADS, before the customer returns product for credit. See the following:
 - a. Must send a copy of the invoice or packing slip with the product and note the RMA#.
 - b. Up to 30 days – no return charge.
 - c. Over 30 days – 15% restocking charge (to include cores).
 - d. It will be at ADS's discretion whether **ADS non-stocking** product or **special order** items may be returned.
 - e. Freight charges will not be credited (excluding warranties).
 - f. It will be at the discretion of ADS to allow merchandise to be returned to satisfy an account.

The growth of Area Diesel Service, Inc. is due to your continuous patronage. Through efficient running of business operations, we can provide for you and your customers low costs. Your cooperation in these credit and return policies will go a long way in helping us to keep your costs down. Please advise the appropriate people in your organization of these terms.

CORE RETURN POLICY

1. An immediate core credit will be issued if a like core is presented and turned in at the same time or the same day; provided the core meets Area Diesel Service's core acceptance policy standards.
2. We reserve the right to refuse to exchange at the flat price any core unit received for the following conditions:
 - a. Core is not in an "as removed from engine condition".
 - b. Damage from improper removal methods.
 - c. Damage from fire, wreck or water.
 - d. Damage from improper packing and shipping.
 - e. Cannibalization of units. (Cannibalizing the rebuildable parts and substituting scrap parts for exchange purposes.)
 - f. Prior disassembly of core and/or reassembled.
3. In the event that no core is presented at the time of purchase, a core charge will be added to the invoice.
4. All core charges must be paid for, or an acceptable core returned within thirty (30) days. Standard terms and conditions apply to core charges.
5. Core credit will be equal to the amount charged on the original invoice for an acceptable core.
6. Once a core charge has been paid, acceptable cores may be returned up to one year for full credit.
7. It shall be at ADS's discretion to purchase or give any credit for said core when returned after the above noted time period of one year.
8. A conversion charge may be applicable, if the core returned is not like-for-like.
9. In order for core credit to be issued, all customers **MUST** supply a copy of invoice or packing slip.

Products without a failure due to defective parts or workmanship will be invoiced to the customer.

Area Diesel Service, Inc.'s, warranty does **NOT** cover progressive damage to the engine or equipment on which the product is installed. Area Diesel Service, Inc. does have product liability insurance. Legitimate claims, when the product is within the warranty period, will be considered on a one-by-one policy basis.

Items that will **NOT** be allowed for warranty consideration are mileage, transportation charges, food, lodging, equipment down-time, equipment rental, loss of profits, communication expense, removal and replacement, towing or labor in waiting or overtime labor.
